The Post 9/11 GI Bill®, Veterans Readiness and Employment (VRE), and the CA State CalVet College Fee Waiver cover the following fees each quarter/academic year. The following fee estimates are based on the 2025-2026 academic year new cohort. Information about non-fee-paying military education benefits are also included on the next page (Chapter 35 Dependents Education Assistance and Chapter 1606 Montgomery GI Bill Selected Reserves). Non-Tuition Paying Military Education Benefits

Chapter 35 Dependents Education Assistance (DEA)/ These numbers are not updated by the VA until Aug/Sept	Monthly Stipend \$1,488 max for a full-time student. Find more about DEA rates here . This benefit does NOT pay any tuition or fees directly to UCSB.
Chapter 1606 Montgomery GI Bill® Selected Reserve/ These amounts are not updated by the VA until Aug/Sept	Monthly Stipend \$466 max for a full-time student. Find more about Ch 1606 rates here . This benefit does NOT pay any tuition or fees directly to UCSB.

IMPORTANT NOTES:

Tuition & fee-specific awards: By law, the VA is the last payor of tuition and registration fees under Chapter 33 and Chapter 31. This means the VA will only pay the balance after the application of any other financial aid that must apply exclusively to tuition & mandatory fees. Examples of fee-specific aid are graduate fee remission, Cal Grant, CalVet College Fee Waiver, UCSB Health Insurance Grant, etc. This does not apply to aid that may be used for any educational cost (may be refunded to the student).

Non-Resident Tuition (NRST) & the VACAA Waiver: Students who have eligibility for Ch 33 Post 9/11 GI Bill®, VR&E Ch 31, Ch 1606 Montgomery GI Bill® Selected Reserve, or Ch 35 DEA, are eligible for the Veterans Access, Choice and Accountability Act (VACAA) Waiver. The VACAA waiver requires that all public institutions of higher learning waive excess non-resident tuition and fees for qualifying veterans and their dependents. This allows the qualifying veteran/dependent to pay in-state tuition, even if they are not considered a California resident.

Yellow Ribbon Program (YR): UCSB is a participant in the Yellow Ribbon Program. However, with the passing of the Isakson and Roe Veterans Health Care and Benefits Improvement Act of 2020, starting in 2021-2022 with the expansion of the VACAA waiver, students who are using the Post 9/11 GI Bill® will no longer need to be awarded Yellow Ribbon as they will only be charged in-state fees. At a public university, YR was historically only for 100% eligible Chapter 33 students who are liable for non-resident tuition (non-resident without a VACAA waiver). It requires that the school pay half the difference between resident and non-resident tuition, and the VA covers the other half. YR is now irrelevant at public universities since recent legislation exempts Chapter 33 participants from Non-Resident Tuition charges.

VA Benefits Eligibility: The Department of Veterans Affairs determines all eligibility for VA benefits - not UCSB.
