B. GRANT INFORMATION

The TEACH Grant Program provides grants of up to \$4,000* a year to FAFSA filers who are completing or plan to complete a program (e.g. <u>TEP</u>) needed to begin a career in teaching. As a condition for receiving a TEACH Grant, you must abide by the obligations listed in the <u>TEACH Grant Counseling and Agreement to Serve or Repay(Agreement)</u>, some of which are agreeing to teach:

- in a high-need field;
- at an elementary school, secondary school, or educational service agency that serves students from low-income families; and
- for at least four complete academic years within eight years after completing (or ceasing enrollment in) the course of study for which you received the grant

*For any **2023-2024 (summer 2023)** TEACH Grant disbursed on or after Oct. 1, 2023, and before Oct. 1, 2024, the maximum award of \$4,000 is reduced by 5.7% (\$228), resulting in a maximum award of \$3,772. However, because summer 2023 is only one quarter, the maximum summer award is up to \$1,257

*For any **2024-2025 (fall 2024, winter 2025, and spring 2025)** TEACH Grant first disbursed on or after Oct. 1, 2024, and before Oct. 1, 2025, the maximum award of \$4,000 is reduced by 5.7% (\$228), resulting in a maximum award of \$3,772 (i.e. \$1,257 per quarter)

C. INITIAL ELIGIBILITY

- Meet academic achievement requirements such as scoring above the 75th percentile on one or more portions of a college admissions test (e.g. GRE) or have an undergraduate or graduate cumulative GPA of at least 3.25
 - Complete the 2023-2024 and 2024-2025 <u>FAFSA</u> and have all required documents submitted to our office (if any) If you are/were an undergraduate student for the 2023-2024 academic year, you will need to update your 2023-2024 FAFSA: college grade level = 1st year graduate/professional, college degree/certificate = college graduate or professional degree, already have first bachelor's degree = yes, and working on a master's or doctorate = yes
- Complete the <u>TEACH Grant Counseling and Agreement to Serve or Repay (Agreement)</u> that explains the terms and conditions of the TEACH Grant service obligations. You must complete both each year in which you will receive the grant (e.g. 2023-2024 and 2024-2025)

D. CONDITIONS OF SERVICE OBLIGATION

If you do not meet the requirements of your service obligation, all TEACH Grant funds you received will be converted to a Direct Unsubsidized Loan. In exchange for receiving a TEACH Grant, you must agree to the following:

- Maintain a cumulative GPA of at least 3.25 throughout the teaching program (e.g. TEP)
- Fulfill the terms of the TEACH Grant Agreement to Serve or Repay (Agreement)
- Complete the TEACH Grant Exit Counseling upon graduating from or withdrawing from the teaching program
- Serve as a full-time teacher for a total of at least four academic years within eight years after you complete or otherwise cease to be enrolled in the program for which you received the TEACH Grant
- Perform the teaching service as a highly qualified teacher in a high-need field at a low-income school or educational service agency
- Provide the Department of Education with documentation of your progress toward completing your service obligation

E. STUDENT CERTIFICATION

I understand that the TEACH Grant program has specific service obligations that must be met in order for the award to remain as a grant. If I fail to meet all the conditions of the TEACH Grant or if the conditions are not documented as required, I understand that the award will be permanently converted to an Unsubsidized Federal Stafford Loan and I will be responsible for repaying this loan with interest calculated from the disbursement date of the grant. I understand that once a TEACH Grant is converted to a loan; it cannot be converted back to a grant.
